Rules and Regulations :

(1) Membership :

In trust there will be members as under.

- (a) Life Members.
- (b) Active Members.
- (c) Social workers and servant members.
- (a) Life Member :

Who give Rs. 1001/- or more amount or Rs. 1001/- of more amount of property give as gift to trust and having interest in activities of trust, he can be life member.

(b) Active member :

- 1 In his life to adopt Khadi completely.
- 2 Mill, Cotton mill cloth and Khadi Gram Udhog that causing hurt, should not connected with such of any activities.
- 3 Three yearly subscription Rs. 151 to be paid.

(c) Social worker and servant Members :

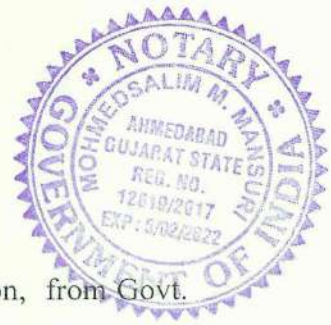
Khadi Gram Udhog of any of activities must be done, and three yearly Rs. 151 Subscription to be paid.

- (2) Financial Arrangement : The below mentioned activities before doing so as per Bombay Public Trust Act of provision that be taken in to consideration.

- (a) To full fill the aims of trust, to run different type of

practical activities, that person/firm, or donation, from Govt. or semi govt. or firm, bank from them donation, help, grant, etc by getting the same can be got.

(b) For progress of activities of trust, instruments, machineries, land, house, or any other type of properties, personal, firm, by donation or managing committee as deem fit and proper with that conditions can be got.

(c) The managing committee as deem fit and proper such securities upon the same can take amount, or borrow, trust of movable or immovable properties upon the same by mortgage or by charge can get amount. Or can adopt. And properties as well as goods, etc can take insurance and upon the same to borrowing firm, such policy can give by doing signature.

(3) General meeting and it's duties :

1 The meeting of all nature of members that will be called general meeting.

2 The presence of 2/3 of members that will be considered as quorum.

3 With written demand of 2/3 members the general meeting can be called. In demand of written application the reasons for calling meeting that to be mentioned.

4 In general meeting with presence of 2/3 members if necessary Rules and Regulations can be changed.

5 If general meeting can be called than in such circumstances with

getting consent of members with majority vote the decision can be taken and such decision will be considered as taken by general meeting.

- 6 In general meeting all the decision and work can be taken by majority votes.
- 7 The general meeting will elect managing committee and their duration will be for three years. He will be liable for re-election.

a- Any of trustee of any reason if be vacated than to appoint other trustee on vacated post that decision can be taken by general meeting.

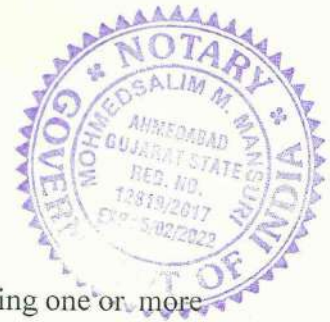
b- In trustee committee of any of change that Gujarat State Khadi Gramudhyog Board that prior permission to be got, and after that the authority of trust Act with the sanction to be got as per rule.

- (8) In general meeting the ending year it's account, report and next year of program be presented.

- (9) For calling general meeting the members will be informed before seven days.

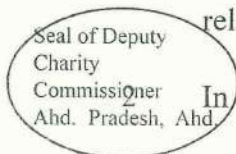
- (10) Till new managing committee be elected that in general meeting elected managing committee be enjoyed the rights thereon as it is.



- (11) For audit of account on each year general meeting one or more auditors can be appointed.
- (12) Generally, the general meeting will be held once in a year, if necessary can be called for more times.
- (13) Pending meeting due to short of quorum that will be held after half an hour on same day, same place, for same work as per agenda and will dispose the work without quorum.
- (14) The prestige of trust, and interest of trust or aims of the trust or activities of trust that intentionally damage than as the trust felt, that general meeting such any of class of member can be rusticated.

(4) Managing Committee :

- 1 The duration of managing committee will be of three years. And there will be minimum of nine members. And in Memorandum there will be maximum of 15 members. But they should not be related with marriage.



- In managing committee minimum of two workers and two ladies.

- 3 In any of circumstances the managing committee if be elected again, than Charity Commissioner /Society Registrar of permission to be got that is compulsory. By getting such permission from competent authority they can be released from



the responsibility of trust. But such members during their post the act which be committed will be responsible for the same.

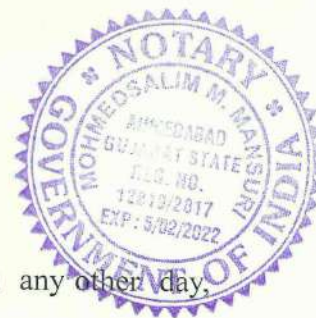
- 4 For president, Vice President, Secretary the election will be made. Their period will be for three years. Will be liable for re-election.
- 5 This trust for daily work President/Vice President and Secretary under their direction do the work.
- 6 Will think over application of new members. And will take decision for sanction.
- 7 The elected member out of them if any one resign than will think over it, and will take decision and on vacant post till new election trustee committee on temporary base that post can full filled.
- 8 The managing committee it's quorum will be with five members. Or 2/3 members which ever is less, by considering same, the meeting will continue.
- 9 In meeting continue three meeting the member can remain absent without showing reason, than will automatically be rusticated.
- 10 The managing committee meeting if be not held, than in such circumstances through circular by getting consent of member, with majority vote decision can be taken.

- 11 The managing committee of three monthly meeting minimum of four times will be held.
- 12 To help to the trust of their different work, the committees or the center where the activities be carried out at that place Honorary administrator can be appointed, and by getting report from him, can think over it.
- 13 In trust new activities be taken on hand and will think over it.
- 14 The profit which be created from activities that will be considered of trust only.
- 15 In work of trust, to the trustees, or active members or the person who helps, to them if necessary will give honorary remuneration and that decision can be taken.
- 16 For salary paid workers, their salary, their grade, bonus, Pro. Fund, rules for leaves, Insurance, and for benefit of workers for the same rules and decision if necessary can be taken.
- 17 Help, donation, gift etc for taking same, to take loan on interest, to decide rate of interest, to decide financial transaction, President, Vice President, Secretar paiki any of one, or to all the necessary powers can be given.
- 18 Monthly Rs.80/- to 3000/- up to that salary and other allowances in that limit getting workers.

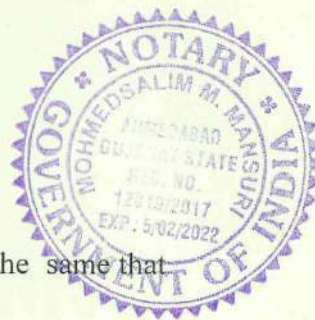


- 19 Due to short of quorum pending meeting on any other day, date, place, time, by deciding same again the meeting be called. The present members will dispose the said work.
- 20 The managing committee meeting will be called by giving information to the members before five days.
- 21 The committee of Certificate through it, rate, rate of sliver, spinning weaving rate, rate of khadi, whatever be increased, and in future which be decided, that trust will obey the same.
- 22 Any of member of trust, for use of trust, as raw material or ready material mill cotton, cloth, cotton-silk, or woolen cloth that will not be used nor do business.
- 23 The trust president, Secretary or other designators, or trustee committee members, will not keep relation with trust or business relation can not be done. And if they personally do business with trust than that to inform in written to managing committee, and sanction to be got, and such transaction to be shown in general meeting. But president, Secretary or any other designator for aims of trust which matching that activities as being other members can take part, that will not be considered as activities of business.

(5) Powers of President :

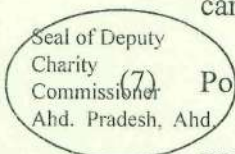
- 1 Will be considered as legal administrator of trust property.



- 2 To do management of trust activities and to run the same that will give necessary instruction direction to the secretary.
- 3 To full fill the aims of trust, and to adopt activities will think over it, and will do instruction to the secretary.
- 4 The powers given to the committee accordingly financial loan, help, documents of property agreement etc can be made.
- 5 The general meeting and Managing committee of authority that all the work with aspect of sanction and without restriction of leaves, general meeting and managing committee meeting can be called.
- 6 The dearness and other allowances within limit of monthly Rs. 800/- getting employee their appointment, suspend and termination can be done.

(6) Powers of Vice President :

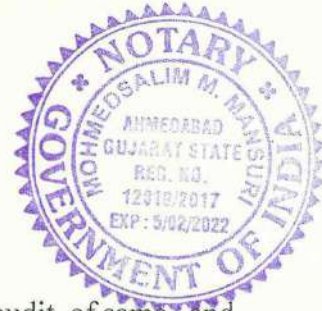
- 1 Will help to president in their work, and in place of him, can enjoy all powers and duty.



Powers of Secretary : 1 The managing committee and President under his direction and instruction under the same will handle all work of trust.

- 2 Will do administration of property of trust and will do correspondent on behalf of trust.

- 3 The aims of the trust accordingly managing committee and instruction and direction of president will adopt activities, and



will do management of same.

4 Will keep all accounts of trust, will get audit of same, and will place before general meeting for sanction.

5 Will take work from salary paid employees, and will guide to them.

6 The salary paid employees, their leaves will sanction and will take decision for giving increment.

7 The powers given by managing committee accordingly financial loan/help, property, documents, agreement etc will be done.

8 All the office file will be under custody of secretary, and to take care that responsibility will be of secretary.

(8) Amount and Properties :

A The amount and property of trust will be considered as ownership of property will be of trust only, and there will be no right of any member or any of other firm.

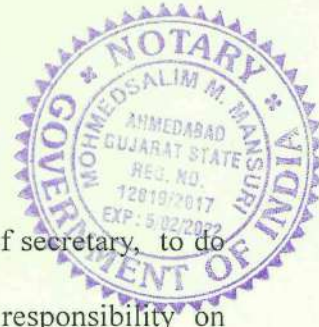
There will be two funds permanent fund and current fund.

Current Fund :

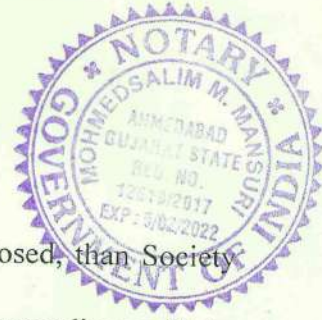

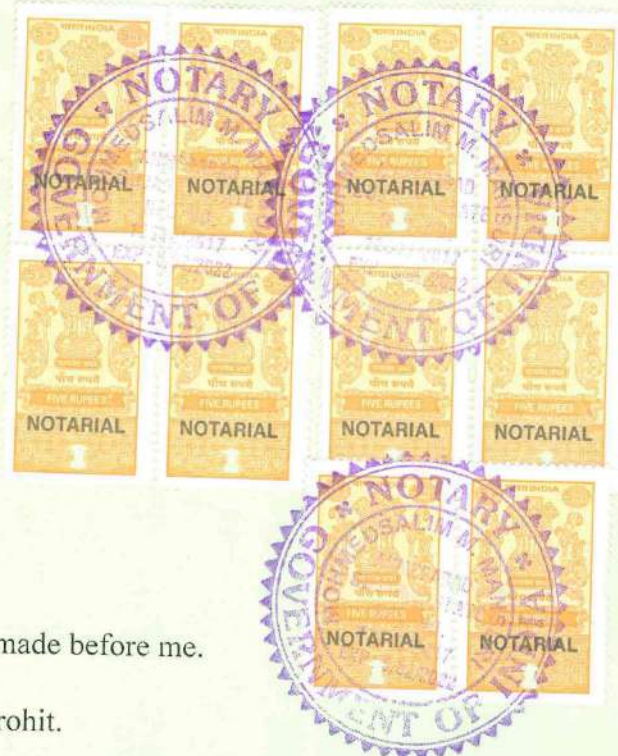
